

## Terms and Conditions of OSW Generic Loan Promotion ("Promotion Offer")

- 1. The Promotion Offer is open to Overseas Workers in Hong Kong ("OSW") who have been approved for a personal loan with any of the following product codes: 899, 900, 905 & 910 ("Personal Loan").
- 2. The Promotion Period is from March 1 to June 30, 2025 (both dates inclusive) ("Promotion Period") and the Redemption Period is based on the loan activation date ("Redemption Period"), as follows:

- 4. The Personal Loan account must be in good financial standing on the date of crediting any Prime Gems Points or primepay Credits. The usage and redemption of Prime Gems Points are subject to Prime Gems Loyalty Club Terms and Conditions and the Prime Gems Points Redemption Terms and Conditions. The usage of the primepay Credits is subject to the primepay Credit Card Cardholder Agreement. If the Personal Loan account is closed for whatever reason, all Prime Gems Points or primepay Credits that have not yet been credited to the Prime Gems Points or primepay account will immediately be forfeited.
- 5. Gift is offered on a first-come-first-served basis and is available while stocks last. In the event of an overwhelming response to the promotion, customers may experience some delay in receiving the gifts. PrimeCredit reserves the right to offer a substitute in case of stock shortage without prior notice.
- 6. The gift redemption letter will be issued to eligible customers immediately after loan drawdown and will not be re-issued if lost or damaged. Gift redemption letters are non-transferable and cannot be exchanged for other gifts or redeemed for cash. Photocopies of the letter are not accepted.

If the Customer makes early settlement regarding the loan within four months from the date of the loan drawdown ("Early Settlement"), the Customer is liable to pay back the value of the Gift (as specified in the table contained herein). PrimeCredit is authorized to deduct the relevant sum from the customer's loan repayment account upon termination of the Customer Relationship. For details, please refer to the Customer Relationship Program letter. For avoidance of doubt, this clause will not prejudice PrimeCredit's rights to terminate any customer relationship at its sole discretion exercised reasonably.
- 8. Customers shall collect the Gift in accordance with PrimeCredit's arrangement and perform the Gift inspection upon receipt of the Gift.
- 9. PrimeCredit is not the supplier of the Supermarket or Retails Store Coupons and will not be responsible for any defects, maintenance and liabilities arising in conjunction with the products and the services provided by the respective suppliers. The use of the Coupons is subject to the term and conditions printed thereon.
- 10. The final interest rate for individual customers will be different and subject to their respective financial status and credit check results. Loan amount and interest rate are subject to PrimeCredit's final approval.
- 11. PrimeCredit reserves the right to cancel or alter the Promotion Offer without prior notice. In case of any disputes, PrimeCredit's decision shall be final and binding. Should there be any inconsistencies between the English and other language versions of the above Terms and Conditions, the English version shall prevail.
